The agreement between the Share Farm arrangement are as follows:-

- All grain delivered to the CBH Storage and handling system is, and at all times has been, owned by the Legal Entities specified in the relevant CBH Accounts making up the Share Farm Account, in the proportions detailed in Section 2. Each Legal Entity will own grain in the relevant proportion.
- The partners comprising the relevant Share Farm arrangement have co-operated together to produce the grain, but are not partners of a partnership.
- Each party is to be paid separately and no party has any interest in the payment entitlements of another party to the Share Farm arrangement.

GRAIN DELIVERED UNDER A SHARE FARM AGREEMENT CAN NOT BE SPLIT ACROSS ACQUIRERS OR PAYMENT METHODS.

CBH is requested and authorised to allocate to the relevant Account detailed in Section 2, the proportions nominated, grain delivered in the name of the Share Farm Account and make payment for that grain in the manner specified by the authorised representative of the Share Farm Account.

It is agreed that if at any time the Agent provides CBH with its Australian Business Number this Authorisation will be immediately revoked, the Agent will be recognised by the CBH Group as the Principal and owner of all future grain deliveries associated with grain delivered as Principal.
